Financial Report

Balance Sheet

End of October is not reflective of our receiving our TIFF Surplus. Our \$11,000 surplus check was sent to the wrong account and it will reflect on our end-of-year balance sheet. We have been a little more conservative this year than last.

Nadeen: What are the risks going into year end? There are no liabilities that is foreseen at this time. We still have not seen the bill from Pressure Washing and don't know where it will land.

P&L

P&L is on target for mostly everything. We are over budget on our customer attraction such as Neighborhood Guide. We printed more guides this year and increased distribution. More strategic on distribution so they last through the year. Watching our Holiday marketing budget and might come under. We talked about maintaining our WBEZ ad placement as well as the Chicago Reader. We want to be strong with marketing for the district.

Façade Rebate Program: We have not paid out Alamo Shoes.

Andy hates the Façade Rebate Program because there shouldn't be a committee that casts judgement on how small businesses choose to their facades to look. Money should go to streetscape elements.

Essa: Program is designed to help small business with larger projects and every penny counts when you it comes to transforming one business, but it has the potential to transform entire blocks with the program. It is a nice perk to have.

Andy would like the Façade Rebate Program funds go to the Security Rebate Program.

Kieren: The incentive lifts the whole neighborhood up. Façade incentive give businesses incentive.

Sullivan: Support of the program and less enamored with the committee. With that said the SSA Commission has final say on awarding the money to applicants.

The Security Camera Rebate we have updated the application to instead or or your choice of providing a narrative of why they choose to give a brief narrative of why they want to go with one bid instead of providing two bids.

The Façade Program is a lot of time to uphold this program. There is a bigger conversation about the program and its future. For right now we should put a pin in the conversation. We should have a representative from the SSA on the Design Committee in addition to having the final say on projects.

2019 RFPs

Landscaping Contract: Gethsemane is our current provider of our Landscape contract. Gethsemane has been a strong partner for over a decade heading into the 2019 season and has re-assessed their bandwidth and focus. They have decided not to bid for landscaping contract with SSA 22. We thank Gethsemane and their incredible team for all their years of service in Andersonville.

The new vendor contract will discuss vision of Andersonville's 52 planters and work with our budget. Topics include:

- -Holiday planters
- -We have not increased our budget on Landscaping
- -Provide itemized list of services that include watering, planting, and materials

Streetscape Maintenance and Landscaping RFP

Kieren and an Andersonville Chamber staff member took a walk about the district to get a sense of the current state of south of foster, post construction, as well as the general health of the streetscape. Planters in prime positions for an update/change to reflect our vibrant streetscape element.

- 1. Compare planters with other neighborhoods
- 2. Pavers throughout the district need repair, replacement, or alignment.
- 3. Construction work (all utility work) should have a contract agreement to restore district.
- 4. Better communication and planning will help guide restoration from alterations of the streetscape.

We must do our due diligence to confirm with Gethsemane that they want to continue working with the SSA. We will not confirm on a Landscaping contract today, but connect on a conference call within a weeks' time to finalize our decision.
